4. Used engines are guaranteed for a period of 30 days from the day of purchase, no exceptions. Guarantee covers replacement or repair of the engine upon approval by White & Bradstreet Inc. only and does not cover labor, towing or any other incidental expenses required to remove or install the engine. We do not guarantee for blown head gasket or overheating due to defective thermostat, water pump, radiator hoses, or insufficient coolant.

5. Oil seals, gaskets, and hoses are not under warranty; they should be replaced upon installation of engines or transmissions

6. All warranty claims must be presented to an authorized agent of White & Bradstreet Inc. prior to any attempts to repair the engine within the warranty period.
